

FAT CAT FONTS LICENSE AGREEMENT FOR USE

By installing the fonts, you are agreeing to be legally bound by the terms of this agreement.

1. Purchasing the font

This font is shareware. You may download it to try, but if you use it for personal or commercial uses, you are required to pay for it. 2. Allowed uses

Once you pay for the font, you may use it for anything that you wish – personal or commercial – including websites, logos, advertising, brochures, magazines, t-shirts, etc. You may also use the licensed font on EPS and other scalable, vector-based graphics.

3. Number of users

Your license allows you one user of the font. You are required to purchase a license for each user of the font. Multi-user license is available, as is a site license. Please contact Fat Cat Fonts at the above website for more information. All users must belong to the same company or household.

4. Third parties

Your license allows you to give a copy of the font to a graphic designer, print vendor, or other organization working on your behalf provided they agree to use the font exclusively for your project, agree to this license agreement, and retain no copies of the font once the project is completed.

You may not distribute the font to any other third parties. This includes distributing it to your friends or on internet websites.

5. Embedding

When you purchase a font, you will be sent an unrestricted version which allows embedding in PDFs and other documents. You may embed the font in documents (PDFs, etc) and websites (cufon, SIFR, etc).

You may outline and modify characters of the font in a vector graphics drawing program such as Adobe Illustrator.

You may not regenerate the font to use, sell or distribute. You may not modify the actual font file (TTF) in any way.
